### Portfolio allocation with quarterly rebalancings for different risk/opportunity profiles, no asset management mandate

- › Platform fee calculated based on account assets
- › No account fee, no transaction fee, no custody fee, no portfolio management fee
- › Financial advisor may choose to pass on trailer fees to investor
- › Financial advisor may add an ongoing service fee and/or a charge on incoming payments
- › Moventum offers fixed investment models in an „execution only“ framework (no active management) for different risk/opportunity profiles, e.g. MOVEeasy inspired by Vanguard funds
- › Quarterly rebalancing
- › Standard reporting
